

**Higher Education Emergency Relief Fund Report–

## **Attachment A**

**Method Used:** Financial Aid staff confirmed all active students at Diamond Beauty College met the following criteria:

- Student is in an active enrollment status as of March 13, 2020
- Student is meeting Satisfactory Academic Progress (SAP)
- Student is receiving Title IV funds with Diamond Beauty College and has a valid 2019/2020 Institutional Student Information Record with no unresolved c-code for citizenship, selective services, default or overpayment.

### **Eligibility Amounts and distribution of the funds**

For the students who have valid 2019-2020 or 2020-21 ISIRs, the academy will distribute \$1,000.00 to those with EFC 0-2800,  
\$750.00 to those with EFC 2801-5576  
\$500.00 to those with EFC over 5576.

There is no application required since all financial aid applicants qualified to receive the grant.

### **Emergency Financial Aid Grants to Students Under the Coronavirus AID, Relief, and Economic Security (CARES) Act**
